ON 7/26/17 AT APPROXIMATELY 1932 HOURS S1, S2 AND S3 WERE CONTACTED AT MOTEL 6 AT [REDACTED] DURING THE CONTACT S1 AND S2 COMMITTED AGGRAVATED ASSAULT ON POLICE BY STRIKING AND KICKING UNIFORMED POLICE OFFICERS. S3 WAS FOUND IN POSSESSION OF DANGEROUS DRUGS.

OFFENSE REPORT

I HAVE BEEN A CERTIFIED POLICE OFFICER SINCE OCTOBER 2008. I AM CURRENTLY ASSIGNED TO THE GATEWAY SECTOR NEIGHBORHOOD RESPONSE SQUAD. THIS SQUAD'S RESPONSIBILITIES INCLUDE PROACTIVE PATROLS OF HIGH CRIME AREAS, APPREHENSION OF FUGITIVES, AS WELL AS INVESTIGATING SUBJECTS RESPONSIBLE FOR REPEATEDLY COMMITTING CRIMES TO INCLUDE GANG RELATED/MOTIVATED CRIMES IN THE CITY OF GLENDALE.

MY TRAINING AND EXPERIENCE INCLUDES THE FOLLOWING: I GRADUATED FROM THE ARIZONA LAW ENFORCEMENT ACADEMY IN 2008. I HAVE COMPLETED BOTH MARIJUANA AND POWDER FIELD TESTING CLASS PROVIDED BY THE ARIZONA DEPARTMENT OF PUBLIC SAFETY. I HAVE CONTINUOUSLY ATTENDED TRAINING RELATED TO NARCOTICS AND RELATED TRENDS. I HAVE OBTAINED THE FOLLOWING TRAINING CLASSES; A 40 HOUR BASIC DRUG INVESTIGATION CERTIFICATION, BASIC SURVEILLANCE, CITY INTERDICTION, INTERVIEW AND INTERROGATION, HUMAN AND SEX TRAFFICKING, ADVANCED REPORT WRITING, CONFIDENTIAL INFORMANTS, SEARCH AND SEIZURE, AND SEARCH WARRANTS FROM ARIZONA HIDTA AND DEA. I HAVE ALSO ATTENDED ANTI TERRORISM TRAINING AND LAW ENFORCEMENT ACTIVE SHOOTER EMERGENCY RESPONSE.

DURING MY CAREER, I HAVE INVESTIGATED OR ASSISTED WITH THE INVESTIGATION OF OVER 200 DRUG CASES. ADDITIONALLY, I HAVE INTERVIEWED DRUG USERS ON HOW METHODS OF CONCEALING ILLEGAL DRUGS TO AVOID DETECTION FROM LAW ENFORCEMENT.

STREET GANG/PRISON GANG, PATRON SAINTS OF THE MEXICAN DRUG UNDERWORLD, SURVIVING MEXICAN CARTEL, PROJECT SAFE NEIGHBORHOOD, HATE CRIMES AND WHITE SUPREMACIST GROUPS.

ON JULY 26, 2017 I WAS WEARING A FULLY IDENTIFIABLE POLICE UNIFORM WITH POLICE MARKINGS IN VARIOUS LOCATIONS ON MY UNIFORM. IN ADDITION TO MY UNIFORM, I WEAR POLICE RELATED EQUIPMENT WHICH MAKES ME EASILY IDENTIFIABLE AS A POLICE OFFICER. I WAS DRIVING AN ALL WHITE POLICE CAR EQUIPPED WITH BOTH RED AND BLUE LIGHTS AND A SIREN.

AT APPROXIMATELY 1932 HOURS I WAS AT THE MAIN POLICE STATION AND I HEARD OFFICER SCHNEIDER AND OFFICER LINDSEY PUT OUT A TRAFFIC STOP AT THE MOTEL 6 LOCATED AT [REDACTED] THIS MOTEL IS KNOWN FOR A LARGE AMOUNT OF CRIMINAL ACTIVITY AND MEMBERS OF MY SQUAD HAVE MADE A LARGE AMOUNT OF ARRESTS FROM THAT AREA OVER THE PAST FEW MONTHS. THERE HAVE BEEN 49 POLICE OFFENSE REPORTS GENERATED FROM THAT ADDRESS IN 2017 ALONE.

A COUPLE MINUTES AFTER THE INITIAL TRAFFIC STOP WAS PUT OUT I HEARD A MIC BREAK WITH SOMEONE SCREAMING IN THE BACKGROUND. I IMMEDIATELY FELT THIS WAS COMING FROM THE TRAFFIC STOP AT [REDACTED] SECONDS LATER I OVERHEARD AN OFFICER SCREAM SEND MORE UNITS. THE VOICE OF THE OFFICER WHO BROADCASTED THE URGENT REQUEST FOR HELP HAD A EXTREME AMOUNT OF STRESS IN HIS VOICE. RADIO RESPONDED BY REQUESTING OFFICERS RESPOND TO [REDACTED] TO ASSIST THOSE OFFICERS ON THE TRAFFIC STOP. I RESPONDED USING MY LIGHTS AND SIREN AND ARRIVED ON SCENE WITHIN APPROXIMATELY 90 SECONDS.

WHEN I ARRIVED ON SCENE I NOTICED THREE POLICE VEHICLES PARKED ON IN THE CENTER DRIVEWAY OF THE MOTEL 6 AND ON THE FAR SOUTHEAST CORNER OF THE DRIVEWAY. AS I EXITED MY CAR I COULD SEE OFFICER LINDSEY ON THE GROUND AGAINST THE EAST WALL. OFFICER LINDSEY WAS NOT MOVING AND THE FIRST THING THAT WENT THROUGH MY MIND WAS HE HAD BEEN SHOT. I RAN SOUTHBOUND TOWARD THE AREA WHERE THE OTHER OFFICERS WERE DEALING WITH A MALE SUSPECT. MY VIEW WAS BLOCKED BY A LARGER VEHICLE BUT I COULD HEAR SCREAMING COMING FROM THE SAME DIRECTION I COULD SEE OFFICER LINDSEY LAYING ON THE GROUND. AT THAT POINT THE OFFICERS ON SCENE WERE OFFICER SCHNEIDER, LINDSEY, FERNANDEZ AND PITTMAN.

AS I CAME AROUND THE CORNER OF THE LARGER VEHICLE I COULD SEE TWO OFFICERS DEALING WITH ONE MALE SUSPECT, ONE MALE SUBJECT

ON THE DRIVERS SIDE OF THE VEHICLE NOT BEING ADDRESSED AND SOME PEOPLE IN THE VEHICLE. I APPROACHED OFFICER SCHNEIDER AND ASKED HIM WHAT HE NEEDED AND HE TOLD ME MARK IS HURT AND THE FEMALE NEEDED TO BE PUT IN HANDCUFFS NOW. HE POINTED POINTED OVER TO THE SOUTH AS HE WAS TELLING ME THIS. I COULD SEE A FEMALE CROUCHED DOWN IN THE CORNER AND I COULD NOT SEE IF SHE WAS HOLDING ANYTHING IN HER HANDS AND I WAS NOT COMPLETELY SURE WHAT TRANSPIRED PRIOR TO MY ARRIVAL. I ORDERED THE FEMALE TO GET ON THE GROUND AND SHE DID NOT IMMEDIATELY COMPLY SO I PULLED HER ONTO THE GROUND AND PLACED HER IN HANDCUFFS. I THEN ESCORTED HER TO MY VEHICLE AND PLACED HER IN THE BACK SEAT.

I WENT BACK OVER TO WHERE THE OTHER OFFICERS WERE ARRESTING THE SUBJECT FROM THE PASSENGER SIDE OF THE VEHICLE. AT THAT TIME ADDITIONAL RESOURCES WERE ARRIVING ON SENE AND THE SUBJECTS WERE ALL DETAINED IN HANDCUFFS.

ONCE THE SCENE WAS UNDER CONTROL I LEARNED OFFICER LINDSEY WAS STRUCK ON THE HEAD WITH A SHOPPING BAG CONTAINING PLASTIC BOTTLES CONTAINING THREE 16.9 OUNCES OF DR PEPPER AND TWO 12 OUNCE CANS OF DR PEPPER. I TOOK OVERALL PHOTOGRAPHS OF THE SCENE TO INCLUDE WITH BAG OF BOTTLES AND CANS. ONE OF THE CANS WERE EMPTY WHEN I PHOTOGRAPHED IT. IT APPEARED THE CAN EXPLODED AS THE BAG WAS VERY WET AND STICKY. THE BOTTLES AND CANS WERE COLLECTED AS EVIDENCE.

I THEN ASSIGNED THE FOLLOWING ASSIGNMENTS:

TOLBERT- INTERVIEWS OF VICTIM OFFICERS SCHNEIDER, FERNANDEZ AND INTERVIEW OF SUSPECT JOHNNY WHEATCROFT

PITTMAN- INTERVIEW OF VICTIM OFFICER LINDSEY

ATEN- COMPLETE TOW OF VEHICLE INVOLVED ON TRAFFIC STOP

SPIWAK- SPEAKING TO CHILDREN, FIND FAMILY MEMBER TO PICK UP CHILDREN AND CONTACT CPS

TRANSPORT OF SUSPECT JOHNNY WHEATCROFT AND SHAWN BLACKBURN WERE HANDLED BY PATROL OFFICERS FERNANDEZ AND DOERR.

I INTERVIEWED SUSPECTS ANYA CHAPMAN AND SHAWN BLACKBURN AND TRANSPORTED SUSPECT ANYA CHAPMAN TO THE GLENDALE CITY JAIL. I TOOK CUSTODY OF THE CRYSTALLINE SUBSTANCE FOUND UNDER THE DRIVERS SEAT, BACKPACK FROM FRONT PASSENGER FLOOR BOARD AND BOLT CUTTERS FROM THE VEHICLE. THOSE ITEMS WERE PHOTOGRAPHED

PRIOR TO BEING LOGGED INTO EVIDENCE.

I LEARNED OF SURVEILLANCE FOOTAGE FROM THE MOTEL 6. I VIEWED THAT SURVEILLANCE FOOTAGE AND MADE THE FOLLOWING OBSERVATIONS.

OFFICER SCHNEIDER AND LINDSEY CONTACT THE OCCUPANTS OF THE VEHICLE ON THE SOUTHSIDE OF THE DRIVEWAY JUST OFF OF GLENN DR. AT APPROXIMATELY 1929 HOURS (ACCORDING TO THE SURVEILLANCE VIDEO'S TIME). THE VEHICLE BACKS INTO THE FIRST SPOT AND THE OFFICERS EXIT THEIR VEHICLE TO APPROACH THE CAR. OFFICER SCHNEIDER APPROACHES THE PASSENGER SIDE AND OFFICER LINDSEY APPROACHES THE DRIVERS SIDE. A SHORT TIME AFTER THE CONTACT BEGINS OFFICER SCHNEIDER GRABS AHOLD OF THE FRONT SEAT PASSENGER. A FEW SECONDS AFTER HE GRABS AHOLD OF THE PASSENGER, OFFICER LINDSEY COMES OVER TO THE PASSENGER SIDE TO ASSIST SCHNEIDER. AT THE SAME TIME LINDSEY GOES AROUND TO THE PASSENGER SIDE OFFICER FERNANDEZ ARRIVES ON SCENE AND APPROACHES FROM THE NORTH. OFFICER FERNANDEZ RUNS TOWARD SCHNEIDER AND LINDSEY TO ASSIST. AT APPROXIMATELY 1931 HOURS LINDSEY AND SCHNEIDER ARE TRYING TO GET THE FRONT SEAT PASSENGER OUT OF THE VEHICLE AND OFFICER LINDSEY IS STRUCK ON THE HEAD BY A WHITE PLASTIC BAG. THIS COMES FROM INSIDE THE VEHICLE AND APPEARED TO BE THE FEMALE WHO DID IT. AT 1932 HOURS OFFICER PITTMAN ARRIVES ON SCENE TO ASSIST AND 1933 HOURS I ARRIVE ON SCENE. THE VIDEO SHOWS ME RUNNING UP TO SCHNEIDER AND THEN TAKENING THE FEMALE WHO STRUCK OFFICER LINDSEY ON THE HEAD INTO CUSTODY AND ESCORTING HER TO MY VEHICLE. THE SUSPECT OFFICER SCHNEIDER WAS FIGHTING WITH WAS TAKEN INTO CUSTODY AND PLACED IN THE BACK SEAT OF A POLICE VEHICLE. A COPY OF THE SURVEILLANCE VIDEO WAS OBTAINED AND DOWNLOADED INTO EVIDENCE.COM

*****INTERVIEW WITH ANYA CHAPMAN*****

I PLACED ANYA INTO AN INTERVIEW ROOM AT THE GLENDALE CITY JAIL AND PROVIDED HER WITH A CUP OF COLD WATER. I ENTERED THE INTERVIEW ROOM AT APPROXIMATELY 2109 HOURS. I READ ANYA HER MIRANDA WARNINGS AND ASKED HER IF SHE UNDERSTOOD HER RIGHTS TO WHICH SHE REPLIED, "YES."

I STARTED BY ASKING ANYA HER PERSONAL INFORMATION TO INCLUDE HER DATE OF BIRTH, SOCIAL SECURITY NUMBER AND PLACE OF WORK. I THEN EXPLAINED TO HER I NEEDED TO GET HER SIDE OF THE STORY FROM WHAT HAPPENED TONIGHT. I TOLD HER TO KEEP IN MIND THE POLICE OFFICERS WERE WEARING BODYCAMERA'S AND THERE WAS ALSO SURVEILLANCE FROM THE MOTEL 6.

I ASKED ANYA TO FIRST TELL ME WHO WAS IN THE CAR AND WHERE THEY WERE SEATED. ANYA TOLD ME HER HUSBAND WAS IN THE FRONT PASSENGER SEAT AND HIS FRIEND (SHE DID NOT KNOW HIS NAME) WAS DRIVING. SHE TOLD ME SHE WAS IN THE BACK SEAT BEHIND THE DRIVER WITH HER TWO SONS SEATED TO HER RIGHT, J [REDACTED] WHEATCROFT [REDACTED])AND B [REDACTED] WHEATCROFT [REDACTED]. ANYA TOLD ME THEY WERE COMING FROM THEIR HOUSE AT [REDACTED] AND SHE INTENDED TO GO TO GET A ROOM AT THE MOTEL 6 SO JOHNNY COULD SPEND TIME WITH THEIR CHILDREN. SHE TOLD ME THEY WERE STOPPED BY THE POLICE IN THE PARKING LOT OF THE MOTEL 6. ANYA TOLD ME THE POLICE WERE ASKING JOHNNY FOR HIS INFORMATION AND HE WASN'T GIVING IT UP BECAUSE HE DOESN'T ROLL LIKE THAT. ANYA TOLD ME SHE GAVE HER ID TO THE OFFICERS AND AT SOME POINT THE OFFICERS WERE TRYING TO GET HER HUSBAND OUT OF THE VEHICLE. THE OFFICERS STRUGGLED WITH HER HUSBAND AND SHE HAD A BAG OF DRINKS AROUND HER WRIST AND SHE WAS REACHING FORWARD TO TELL JOHNNY TO STOP BECAUSE THEY HAD THERE TASERS ON HIM AND THAT SCARED HER. SHE TOLD ME THAT WAS WHEN THE OFFICER WAS THERE WHERE SHE SWUNG THE BAG. SHE TOLD ME SHE DIDN'T REALIZE THE OFFICER WAS THERE AND IT WAS NOT INTENTIONAL. SHE TOLD ME SHE HAD A BAG OF DRINKS ATTACHED TO HER WRIST AND THAT IS THE ONLY TIME SHE COULD THINK OF THAT SHE HIT THE COP. I ASKED HER WHAT THE TURNING POINT WAS FOR JOHNNY TO START RESISTING ARREST AND SHE TOLD ME SHE DIDN'T THINK IT HAD TO GO THAT FAR AND JOHNNY HAD NEVER RESISTED ARREST TO HER KNOWLEDGE. SHE WENT ON TO TELL ME JOHNNY KEPT ASKING WHAT HE DID WRONG TO BE REQUIRED TO GIVE UP HIS INFORMATION.

I ASKED ANYA WHAT SHE THOUGHT HAPPENED TO THE OFFICER WHO WAS HIT WITH HER BAG OF BOTTLES AND SHE SAID SHE THOUGHT THE OFFICER GOT BACK UP AND CONTINUED TO TASE HER HUSBAND. SHE TOLD ME AGAIN SHE DIDN'T INTENTIONALLY HIT THE OFFICER IN THE HEAD. I INFORMED HER THE OFFICER ACTUALLY WAS KNOCKED TO THE GROUND AND LOSS CONSCIOUSNESS. WHEN I INFORMED HER OF THIS SHE ROLLED HER EYES. I ALSO EXPLAINED TO HER THE OFFICER WAS ULTIMATELY TRANSPORTED TO THE HOSPITAL AND SHE SHOOK HER HEAD BACK AND FORTH IN DISBELIEF. ANYA TOLD ME SHE JUST SAW THE OFFICER AND I TOLD HER SHE DID NOT BECAUSE HE WAS IN THE HOSPITAL. I INFORMED HER SHE WAS BEING CHARGED WITH AGGRAVATED ASSAULT ON A POLICE OFFICER WITH SERIOUS PHYSICAL INJURY AND THAT WAS A CLASS TWO FELONY. ANYA TOLD ME SHE THINKS SHE NEEDS A LAWYER AND I STOPPED THE INTERVIEW AND EXITED THE ROOM.

END OF INTERVIEW WITH ANYA.

HE THEN ASKED ME IF HE WAS GOING TO BE BOOKED INTO JAIL TONIGHT AND WHAT THE CHARGES WERE. I TOLD HIM I COULD NOT ANSWER HIM BECAUSE I DID NOT KNOW.

I EXPLAINED TO SHAWN THAT MY JOB WAS TO GATHER FACTS OF THE WHAT HAPPENED AND DOCUMENT THE FACTS IN A REPORT. I TOLD HIM THE REPORTS WOULD BE PRESENTED TO THE MARICOPA COUNTY ATTORNEY'S OFFICE AND THEY WOULD MAKE A DECISION ON CHARGING.

I ASKED SHAWN TO TELL ME WHAT HAPPENED TODAY. HE TOLD ME HIS FRIEND JOHNNY AND HIS WIFE WERE FIGHTING AND JOHNNY WAS KICKED OUT OF THE PLACE THEY WERE STAYING AT. HE WENT ON TO TELL ME HE PICKED THEM UP TO TAKE THEM TO THE MOTEL 6 SO THEY COULD SPEND TIME TOGETHER. HE TOLD ME JOHNNY GOT INTO THE CAR WITH SEVERAL BAGS INCLUDING A BROWN BACKPACK AND A LARGER BAG THAT WENT IN THE TRUNK. AS THEY WERE PULLING INTO THE MOTEL, THEY WERE STOPPED BY OFFICERS. I TOLD HIM THE OFFICER TOLD ME THE REASON FOR THE STOP WAS HIM FAILING TO USE HIS TURN SIGNAL. I ASKED HIM IF HE REMEMBERS NOT USING IT AND HE TOLD ME HE COULDN'T TELL ME IF HE DID OR DID NOT. I ASKED HIM IF THE OFFICERS TURNED ON THEIR RED AND BLUE LIGHTS AND HE THOUGHT THEY DID. SHAWN TOLD ME JOHNNY WAS TALKING TO THE OFFICER ON THE PASSENGER SIDE AND WAS NOT PROVIDING HIS INFORMATION. HE TOLD ME JOHNNY INDICATED HE KNEW HIS RIGHTS AND DID NOT HAVE TO GIVE UP HIS ID UNLESS THE DRIVER WAS ARRESTED. SHAWN TOLD ME HE DIDN'T KNOW IF THAT WAS TRUE OR NOT. I ASKED SHAWN IF HE HEARD THE DISCUSSION ABOUT JOHNNY AND BEING TOLD TO NOT PUT HIS HAND IN HIS BACKPACK. HE TOLD ME HE HEARD THE OFFICER TELL HIM TO NOT REACH IN THE BACK PACK AND JOHNNY TOLD HIM HE DIDN'T HAVE TO AND JOHNNY TURNED HIS BODY AWAY FROM THE OFFICER TO PUT THE BACKPACK IN THE BACK SEAT OR TO HAND IT TO SOMEONE. SHAWN WENT ON TO TELL ME THE OFFICERS WERE GETTING SHAWN OUT OF THE VEHICLE AND HE WAS NOT LISTENING TO THEM. HE TOLD ME THERE WAS A LOT GOING ON AND HE ONLY COULD REMEMBER SO MUCH BUT HE DIDN'T THINK JOHNNY WAS RESISTING MUCH.

I ASKED SHAWN WHEN HE LAST USED AND HE TOLD ME HE LAST USED METHAMPHETAMINE FOUR MONTHS AGO. IT APPEARED AS SHAWN WAS TELLING THE TRUTH. HE WENT ON TO TELL ME HE RECENTLY DID A HAIR FOLLICLE TEST TO PROVE TO HIS FAMILY HE WAS NOT CURRENTLY USING. I ASKED HIM IF HE POSSIBLY LEFT IT THERE AND IT WAS OLD AND SHAWN TOLD ME ANYTHING WAS POSSIBLE. ULTIMATELY, JOHNNY DID NOT ADMIT TO POSSESSION OF THE METHAMPHETAMINE AND TOLD ME HE HASN'T USED IN FOUR MONTHS. I HAD SHAWN PHOTOGRAPHED AND FINGERPRINTED AND HE WAS RELEASED. END OF INTERVIEW WITH SHAWN.

I TOOK PHOTOGRAPHS OF JOHNNY TO INCLUDE HIS TATTOOS AND HIS OVERALL CONDITION. THIS WAS DONE AFTER OFFICER TOLBERT COMPLETED THE INTERVIEW WITH JOHNNY AND JUST PRIOR TO ME LEAVING THE JAIL.

*****REVIEW OF OFFICER SCHNEIDER'S BODY CAMERA*****

ON JULY 27TH I VIEWED THE BODYCAMERA OF OFFICER SCHNEIDER. DURING THE INCIDENT HIS BODY CAMERA SHOWED ANYA LEANING FROM THE BACK SEAT FORWARD INTO THE FRONT SEAT TO PICK UP THE BAG OF DRINKS AND SWING IT TOWARD THE OFFICERS DIRECTION. DURING THAT TIME SHE IS YELLING FOR THEM TO STOP THE DRIVE-STUN ON HER HUSBAND. IT WAS CLEAR ANYA WAS TRYING TO SWING THE BAG OF BOTTLES IN THE DIRECTION OF THE OFFICERS TO STOP THEM FROM THE DRIVE-STUN ON HER HUSBAND.

I WEIGHED THE BOTTLES AND CANS COLLECTED FROM THE SCENE AND THE TOTAL WEIGHT WAS JUST OVER FIVE POUNDS. I PHOTOGRAPHED THE BOTTLES AND CANS ON THE SCALE. I ALSO PHOTOGRAPHED A GALLON OF WATER ON THE SCALE AND THAT WEIGHT WAS JUST OVER EIGHT POUNDS.

I PHOTOGRAPHED THE CONTENTS OF THE BACKPACK AND NOTICED THERE WAS 23 CELLULAR PHONES, JEWELRY AND A WALLET WITH JOHNNY'S PERSONAL ITEMS ALONG WITH OTHER PEOPLES CARDS.

ALL SEIZED EVIDENCE WAS LOGGED UNDER THIS REPORT NUMBER. THE CRYSTALLINE SUBSTANCE FOUND UNDER THE DRIVERS SEAT FIELD TESTED POSITIVE FOR METHAMPHETAMINE.

AT THE TIME OF WRITING THIS REPORT OFFICER LINDSEY WAS RELEASED FROM THE HOSPITAL BUT HAS NOT RETURNED TO WORK. THE EXTENT OF HIS INJURIES ARE UNKNOWN AT THIS TIME.

JOHNNY RESEMBLED A PERSON I HAD CONTACTED WITH OFFICER LINDSEY SEVERAL MONTHS PRIOR WHO HAD BEEN RIDING A BICYCLE IN THE AREA OF 59TH AVENUE AND BETHANY HOME ROAD.

I BRIEFLY WAS STANDING IN THE AREA WHERE JOHNNY WAS, AND I ASKED HIM IF I HAD STOPPED HIM ON A BICYCLE A FEW MONTHS BEFORE. JOHNNY AFFIRMED THIS AND SAID THAT HAD BEEN HIM.

OFFICER LEWIS REQUESTED I INTERVIEW OFFICERS SCHNEIDER AND FERNANDEZ ALONG WITH (SUSPECT) JOHNNY WHEATCROFT.

OFFICER SCHNEIDER INTERVIEW

I INITIALLY SPOKE TO OFFICER SCHNEIDER WHO I OBSERVED TO BE WEARING A FULLY MARKED POLICE UNIFORM. I AM AWARE OFFICER SCHNEIDER OPERATES A FULLY MARKED GLENDALE POLICE DEPARTMENT CHEVROLET TAHOE AS HIS POLICE VEHICLE. OFFICER SCHNEIDER STATED HE HAD OBSERVED THE LISTED VEHICLE (FORD TAURUS) FAIL TO USE ITS TURN SIGNAL WHEN IT DROVE FROM GLENN DRIVE INTO THE MOTEL 6 PARKING LOT (THE DRIVEWAY BY THE MOTEL OFFICE).

AS A RESULT, A TRAFFIC STOP WAS GOING TO BE CONDUCTED BASED ON THIS VIOLATION. OFFICER SCHNEIDER SAID AS HE DROVE AROUND THE NORTHSIDE OF THE LOT, HE OBSERVED THE FORD TAURUS SOUTH OF HIM. THE VEHICLE TRIED BACKING INTO A PARKING SPACE VERY QUICKLY.

OFFICER SCHNEIDER MADE CONTACT AT THE PASSENGER SIDE OF THE VEHICLE WHILE OFFICER LINDSEY CONTACTED THE DRIVER'S SIDE. OFFICER SCHNEIDER SAID HE BELIEVED THERE WAS A MALE DRIVER

OFFICER SCHNEIDER SAID HE ASKED JOHNNY FOR HIS IDENTIFICATION. JOHNNY PROCEEDED TO ARGUE WITH OFFICER SCHNEIDER THAT HE DID NOT HAVE TO PROVIDE HIS INFORMATION. JOHNNY WAS VERBALLY DEFIANT SAYING THE OFFICERS SHOULD BE TALKING TO THE DRIVER AND NOT HIM.

OFFICER SCHNEIDER SAW JOHNNY HAD A BROWN BACKPACK THAT HE PUT HIS HAND INSIDE OF. OFFICER SCHNEIDER TOLD JOHNNY TO NOT GO INTO THE BACKPACK. JOHNNY THEN QUICKLY TURNED HIS BACK TOWARDS OFFICER SCHNEIDER. THIS CAUSED JOHNNY TO BE FACING TOWARDS THE CENTER CONSOLE. OFFICER SCHNEIDER BELIEVED JOHNNY WAS STICKING HIS HAND IN BETWEEN THE SEAT AND CONSOLE. AT THIS POINT IN THE CONTACT, OFFICER SCHNEIDER DID NOT KNOW IF THERE WERE ANY WEAPONS IN THE VEHICLE OR ON JOHNNY.

OFFICER SCHNEIDER THEN GRABBED A HOLD OF JOHNNY'S ARM. HE FELT JOHNNY'S ARM TENSE UP, AND OFFICER SCHNEIDER WARNED HIM TO STOP TENSING UP HIS ARM. HE BELIEVED JOHNNY WAS TRYING TO RESIST AND PULL AWAY FROM HIM. AT ONE POINT, OFFICER SCHNEIDER UNHOLSTERED HIS TASER AND TOLD JOHNNY HE WAS GOING TO BE TASED IF HE CHOSE TO FIGHT WITH OFFICERS.

OFFICER LINDSEY CAME TO THE PASSENGER SIDE TO ASSIST OFFICER SCHNEIDER. OFFICER SCHNEIDER REPORTED HE COULD HEAR YELLING AND CRYING INSIDE OF THE CAR. OFFICER SCHNEIDER BELIEVED THE ADULT FEMALE (ANYA) WAS YELLING SOMETHING TO THE EFFECT OF "HE WASN'T DOING ANYTHING" AND YELLING OTHER PROFANITIES.

OFFICER SCHNEIDER BELIEVED JOHNNY WAS TRYING TO PULL AWAY FROM HIM AND OFFICER LINDSEY BY PULLING ON THE SEAT TO GET TOWARDS THE DRIVER'S SIDE. OFFICER SCHNEIDER SAID JOHNNY WAS KICKING HIS LEGS AND MAKING IT DIFFICULT TO RESTRAIN HIM.

OFFICER SCHNEIDER SAID HE REMEMBERED SEEING A BAG BEING FLUNG FORWARD FROM THE BACKSEAT. OFFICER SCHNEIDER SAW OFFICER LINDSEY FALL BACKWARDS AND WHEN HE LOOKED THAT DIRECTION, HE SAW OFFICER LINDSEY APPEARED TO BE UNCONSCIOUS ON THE GROUND. OFFICER SCHNEIDER LATER LEARNED THE BAG ANYA SWUNG FORWARD HAD HIT OFFICER LINDSEY IN THE HEAD.

OFFICER SCHNEIDER HAD RADIOED FOR URGENT BACK-UP BASED ON THE

OFFICER SCHNEIDER BELIEVED HE WAS KICKED NUMEROUS TIMES TO HIS LOWER EXTREMITIES. HE ALSO BELIEVED HE WAS KICKED BY JOHNNY TO HIS RIGHT HAND WHEN HE WAS HOLDING HIS TASER.

WHEN I LOOKED AT OFFICER SCHNEIDER'S PANTS, I SAW A DUSTY MARK ON THE FRONT OF HIS CROTCH AREA. THERE ALSO WAS SOME DUSTY MARKS ON THE LOWER AREAS OF HIS BLACK PANT LEGS. OFFICER SCHNEIDER LIFTED UP HIS RIGHT PANT LEG AND I OBSERVED SOME LIGHT ABRASIONS ON HIS RIGHT SHIN. OFFICER SCHNEIDER SAID HIS INJURIES WERE SUPERFICIAL, AND HE DID NOT REQUIRE MEDICAL ATTENTION. OFFICER LEWIS ULTIMATELY TOOK PHOTOGRAPHS OF OFFICER SCHNEIDER.

OFFICER SCHNEIDER BELIEVED HE HAD A FULL DEPLOYMENT OF HIS TASER AGAINST JOHNNY. HE INDICATED HE HAD RE-ENERGIZED HIS TASER AS WELL. OFFICER SCHNEIDER BELIEVED OFFICER FERNANDEZ UTILIZED HIS TASER ALSO.

ULTIMATELY, JOHNNY WAS TAKEN OUT OF THE CAR AND ONTO THE GROUND. OFFICER SCHNEIDER SAID JOHNNY CONTINUED FIGHTING ON THE GROUND. JOHNNY WAS INITIALLY HUNG UP IN THE SEATBELT OF THE PASSENGER SEAT, BUT WHEN HIS FEET BECAME FREED, JOHNNY CONTINUED KICKING AT OFFICER SCHNEIDER STRIKING HIM IN HIS LEGS.

OFFICER SCHNEIDER BELIEVED JOHNNY WAS TRYING TO FIGHT WITH OFFICERS AND WAS NOT JUST TRYING TO GET AWAY.

OFFICER SCHNEIDER SAID EVEN AFTER JOHNNY WAS IN HANDCUFFS HE WAS STILL TRYING TO KICK AT OFFICERS.

OFFICER SCHNEIDER STATED HE DESIRED PROSECUTION AGAINST JOHNNY FOR AGGRAVATED ASSAULT. OFFICER SCHNEIDER WAS WEARING A POLICE BODY-WORN CAMERA THAT WAS UTILIZED DURING THIS INCIDENT.

AFTER INTERVIEWING OFFICER SCHNEIDER, I WAS MADE AWARE THE INCIDENT WAS CAPTURED ON SURVEILLANCE VIDEO FROM THE MOTEL 6. I PROCEEDED INTO THE LOBBY IN ORDER TO VIEW IT.

OFFICER LINDSEY GOES TO THE DRIVER'S SIDE, AND THE DRIVER GOT BACK IN THE CAR. ANYA IS OBSERVED STANDING IN THE DOORWAY OF THE DRIVER REAR DOOR. IT APPEARS ANYA IS WEARING HER PRESCRIPTION GLASSES.

OFFICER SCHNEIDER IS OBSERVED OPENING THE PASSENGER FRONT DOOR AND LOOKED TO GRAB A HOLD OF THE PASSENGER. IT THEN APPEARED AS THOUGH OFFICER SCHNEIDER REMOVED HIS TASER FROM HIS OUTER VEST CARRIER (CROSS DRAW). OFFICER SCHNEIDER EVENTUALLY HOLSTERED HIS TASER, BUT THEN GRABS A HOLD OF THE PASSENGER WITH BOTH OF HIS HANDS.

OFFICER FERNANDEZ ARRIVED IN THE PARKING LOT AND EXITED HIS POLICE VEHICLE. OFFICER LINDSEY BEGAN MOVING TOWARDS THE PASSENGER SIDE OF THE CAR TO ASSIST OFFICER SCHNEIDER. OFFICER LINDSEY APPEARED TO WAVE OFFICER FERNANDEZ TOWARDS THE SITUATION, AND OFFICER FERNANDEZ BEGAN MOVING TOWARD THE TAURUS QUICKLY.

IT IS APPARENT ON THE VIDEO A STRUGGLE WAS ENSUING, BUT DUE TO THE PASSENGER CAR DOOR BEING OPEN, I WAS NOT ABLE TO DISCERN SPECIFIC ACTIONS OCCURRING DURING THE STRUGGLE (THE VIEW WAS BLOCKED BY THE OPENED DOOR). FOR EXAMPLE, I COULD NOT SEE CLEARLY IF JOHNNY WAS KICKING THE OFFICERS. OFFICER FERNANDEZ SAID HE HEARD NRS (NEIGHBORHOOD RESPONSE SQUAD) OFFICERS CONDUCT A TRAFFIC STOP AT THE MOTEL 6 OVER HIS POLICE RADIO. DUE TO HIS CLOSE PROXIMITY, OFFICER FERNANDEZ SAID HE WAS GOING TO RESPOND AS A BACK-UP UNIT.

WHEN HE ARRIVED IN THE CENTER PARKING LOT, OFFICER FERNANDEZ SAW THE OTHER POLICE OFFICERS WERE MAKING CONTACT WITH A BACKED IN VEHICLE (FORD TAURUS). OFFICER FERNANDEZ BELIEVED THE INTERACTION WITH OFFICER SCHNEIDER WAS BECOMING MORE AGGRESSIVE WITH THE FRONT SEAT PASSENGER (JOHNNY WHEATCROFT). OFFICER FERNANDEZ THEN SAW OFFICER LINDSEY FALL BACKWARDS, BUT NEVER SAW HIM GET BACK UP AGAIN. OFFICER FERNANDEZ REMEMBERS HEARING, "I'M HURT" OR "HE'S HURT".

OFFICER FERNANDEZ THEN RAN TO THE PASSENGER SIDE OF THE TAURUS IN ORDER TO HELP OFFICER SCHNEIDER WITH TAKING JOHNNY INTO CUSTODY. OFFICER FERNANDEZ SAID HE REMEMBERED HEARING "GIVE US YOUR HANDS" AND "STOP RESISTING" DURING THE STRUGGLE WITH JOHNNY.

OFFICER FERNANDEZ ALSO REPORTED HE COULD HEAR THE CHILDREN IN THE CAR CRYING, "MY DAD, MY DAD" ALONG WITH "LEAVE HIM ALONE."

OFFICER FERNANDEZ SAID HE SAW TASER PROBES COMING FROM JOHNNY SO HE BELIEVED A PREVIOUS DEPLOYMENT HAD NOT BEEN EFFECTIVE. OFFICER FERNANDEZ SAID HE DEPLOYED HIS TASER AT JOHNNY. HE BELIEVED THIS EFFORT WAS EFFECTIVE BECAUSE IT SEEMED TO LOCK-UP JOHNNY'S MOVEMENTS CAUSING HIM TO STOP FIGHTING MOMENTARILY.

OFFICER FERNANDEZ SAID JOHNNY WOULD FIGHT, KICK, AND THRASH AROUND, BUT THEN STOP WHEN THE TASER WAS USED. THIS BEHAVIOR WAS REPEATED. I ASKED OFFICER FERNANDEZ IF HE BELIEVED JOHNNY'S ACTIONS WERE BEING DONE TO FIGHT WITH OFFICERS OR IF THEY WERE BEING DONE TO ESCAPE FROM OFFICERS. OFFICER FERNANDEZ SAID HE WAS UNSURE.

JOHNNY SAID THE POLICE CAR WAS DRIVING AWAY FROM OTHER PEOPLE, AND HE BELIEVED THE POLICE HAD HARASSED THOSE PEOPLE DURING THE OFFICERS' ROUTINE PATROL.

JOHNNY SAID THE POLICE CAR HAD HEADED WEST IN THE NORTH ALLEYWAY. I TOLD JOHNNY I WAS TOLD THE VEHICLE HE WAS TRAVELING IN WAS OBSERVED BY OFFICERS TO NOT USE ITS BLINKER TURNING INTO THE PARKING LOT.

SGT GALLAGHER'S INTERVIEW OF JOHNNY WHEATCROFT SUMMARY:

SGT. GALLAGHER ASKED JOHNNY IF HE HAD ANY CONCERNS ABOUT WHAT HAPPENED OUT AT THE SCENE. JOHNNY STATED THAT HE WAS HURT. SGT. GALLAGHER ASKED HIM WHAT'S GOING ON WITH HIM. INTERVIEW OF OFC. M. LINDSEY

ON SEPTEMBER 1, 2017 AT APPROX. 0840 HOURS, I MET WITH OFC. MARK LINDSEY IN MY OFFICE AT THE GLENDALE POLICE DEPARTMENT MAIN STATION. I ADVISED OFC. LINDSEY THAT I WOULD BE INTERVIEWING HIM ABOUT THE AGGRAVATED ASSAULT INCIDENT THAT HAPPEN ON JULY 26, 2017 AT THE PARKING LOT. I ADVISED OFC. LINDSEY THAT I WOULD BE RECORDING THE INTERVIEW. I THEN TURN ON MY DIGITAL RECORDER AND INTRODUCE MYSELF AND OFC. LINDSAY AT THE BEGINNING OF THE RECORDING.

OFC LINDSEY STATED THAT THE MOTEL 6 HAS BEEN A TARGET AREA FOR THEIR SQUAD FOR SOME TIME BASED UPON RESPONDING TO CALLS FOR SERVICE FOR DRUG SALES, OVERDOSES AND DRUG USE. HE ALSO NOTED THAT THEY HAD FOUND STOLEN CARS IN THE PARKING ON PREVIOUS OCCASIONS.

I ASKED OFC. LINDSEY IF ON JULY 26, 2017 IF THEY HAD COME ACROSS A GREY IN COLOR FORD TAURUS IN THE PARKING LOT OF THE MOTEL 6. OFC. LINDSEY STATED THAT THEY HAD. I ASKED OFC. LINDSEY WHAT HAD PROMPTED THE TRAFFIC STOP OF THE FORD TAURUS THAT DAY. OFC. LINDSEY REPLIED, "WE WERE COMING THROUGH THE NORTH PARKING LOT, THE PARKING LOT IS DIVIDED INTO THREE SECTIONS... WE COMING ON THE NORTH SIDE PASSAGEWAY WHEN OFC. SCHNEIDER LOOKED DOWN TO THE LEFT OF THE MIDDLE TO SEE IF ANYONE WAS DOWN THERE. HE OBSERVED THE VEHICLE PULLING IN. OFC LINDSEY STATED, "SO WHEN SCHNEIDER SAID HE SAW THE

I SHOWED OFFICER LINDSEY A GOOGLE SATELLITE MAP THE MOTEL 6 WITH THE SURROUNDING STREETS AND ALLEY. I ASKED OFFICER LINDSEY TO POINT TO WHERE THEY WERE IN A MAP JUST TO CLARIFY. ON FRIDAY, SEPTEMBER 1, 2017 AT APPROXIMATELY 1320 HRS. I INTERVIEWED OFFICER M. FERNANDEZ IN MY OFFICE. I EXPLAINED OFFICER FERNANDEZ WYATT I HAD ASKED HIM TO COME IN FOR AN INTERVIEW AND ALSO ADVISED HIM THAT I WOULD BE RECORDING THE INTERVIEW AND PLACED THE DIGITAL RECORDER BETWEEN HIM AND I ON MY DESK. AFTER GOING OVER THE DR NUMBER DATE TIME AND LOCATION OF THE INCIDENT I ASKED OFFICER FERNANDEZ IF HE HAD ACTIVATED HIS BODY CAM DURING THE INCIDENT. OFFICER FERNANDEZ STATED THAT HE DID NOT RECALL ACTIVATING HIS BODY CAM. I ALSO DID NOT FIND ANYBODY CAM FOOTAGE FROM OFFICER FERNANDEZ AND EVIDENCE.COM.

I ASKED OFFICER FERNANDEZ WHAT HAD PROMPTED HIM TO GO TO THE MOTEL 6 THAT EVENING. OFFICER FERNANDEZ STATED THAT HE OVERHEARD THE RADIO TRAFFIC OF OFFICER SCHNEIDER THAT THEY WERE GOING I WITH A VEHICLE AT THE MOTEL 6 PARKING LOT.

OFFICER FERNANDEZ STATED THAT HE WAS NEAR 103 AT THE TIME AND DECIDED TO GO THAT WAY TO ACT AS A BACKUP.
